BOOKING INFORMATION REMINDER

All current balances for 'regular' users (not those using childcare vouchers / tax free childcare) must be cleared (i.e. paid off) before new bookings can be made.

Families should not feel the need to book a term in advance, as we have the capacity to manage all current bookings and an additional margin of increased spaces if required.

Please also note bookings will close **24 hours** before a scheduled session. If you need alter a booking at anytime, please contact the OSC email but also copy in **your child's school office email**.

Bookings made after the booking session has closed are termed as 'Ad hoc bookings' and there is additional fee for these bookings which will be added automatically.

We have made a change to the prices and a letter will follow separately:

Polecats BSC (Before School Club)

- £6.50 per session (booked in advance)
- £9.00 per session (ad-hoc bookings)

Polecats ASC (After School Club)

- £12.50 per session (booked in advance)
- £16.00 per session (ad-hoc bookings)

Please also note that children must be collected promptly at the end of each ASC session. A new per minute charge will be in place from September. Any late collection will be charged at £2 per minute from 6pm.

TERMS AND CONDITIONS REMINDERS

We wanted to take the opportunity to remind everyone that uses the OSC of a few rules that need to be followed.

From September the opening times for Breakfast club will be: 7.40-8.50 and After School club is 15.10-18.00. Please can we remind all parents that all children must be picked up by 6pm.

When dropping your children off in the morning please make sure you are bringing them into the office and handing them over to a member of staff. We have had a few incidents where parents are dropping children off at the gate which is not allowed.

Please make sure you inform us of other people are collecting your child from the ASC. We can not let children leave with unknown people without written consent . If someone is picking your child up please let the OSC team AND your child's school office.
